

Coronavirus disease 2019 (COVID-19) Daily Situation Report <u>12 July 202</u>0

Global Update (02:00-CET time)

World Health Organization

• Globally, the cumulative figure reached the 12M mark; a total of 12,552,765 cases, including 561,617 deaths have been reported; since mid-July, increase in the daily trend of cases has been observed, with figures ranging between 140,000 to 230,000; meanwhile, daily death toll has stabilized; global CFR has decreased from 5.0% to 4.0%.

• Among the WHO regions, Americas still has the highest burden of cases, representing 51% of the global burden of 12,552,765 cases; European region, Eastern Mediterranean, SEARO, AFRO and WPRO represent 23%, 10%, 9%, 4% and 2%, respectively, of the global burden of cases; five countries in the Americas are included in the top 12 of countries with the highest case load; 3 countries in EURO, 2 countries in the EMR, 1 in SEAR and 1 in AFRO are also in the top 12.

• The top 12 countries with the highest case count are (in descending order): USA, Brazil, India, Russian Federation, Peru, Chile, Mexico, United Kingdom, South Africa, Iran, Spain and Pakistan.

• In regard to CFR, USA and Brazil remain at 4.0%, which is below the global CFR; USA still topped the countries in terms of cumulative death toll (133,486 deaths); after several days of recording less than a thousand deaths per day, a spike in the number of deaths was recorded on 27 June with more than 2,500 deaths, since then, daily death count went back to less than a thousand.

• Other countries with the highest cumulative death toll after USA (in descending order) are Brazil, United Kingdom, Italy, Mexico, France, Spain, India, Iran, Peru, Russian Federation and Belgium. United Kingdom, Italy, France, Spain and Mexico exceed the global CFR.

• Countries/territories/areas with no new cases for >14 days: Saint Barthélemy (102 days), Anguilla (98 days), Lao PDR (89 days), Timor-Leste (78 days), Falkland Islands (Malvinas) (76 days), Guernsey (69 days), Holy See (65 days), Brunei Darussalam (64 days), United Republic of Tanzania (64 days), British Virgin Islands (56 days), Isle of Man (50 days), International commercial vessel (49 days), Equatorial Guinea (48 days), Bonaire, Saint Eustatius and Saba (46 days), Grenada (45 days), Greenland (43 days), Monaco (34 days), New Caledonia (31 days), Dominica (28 days), Saint Vincent and the Grenadines (23 days), Andorra (22 days), San Marino (21 days), Papua New Guinea (15 days).

Regional Update: (18:00-Cairo time)

• As of 12 July 2020, a total of 1,281,924 cases have been reported in the EMR since the start of the outbreak, which still represents 10.0% of the global burden of 12,552,765 cases reported to date. Globally, Iran remains at the 10th position of countries with the heaviest case load.

• In regard to EMRO, Iran continues to represent 20% of the Regional burden of 1,281,924 cases; from week 25, the number of cases has reached its plateau. Today, 2,186 were reported; more than 25,000 tests were conducted in the past 24 hours giving a total of nearly 2 million tests since the start of the outbreak.

• Pakistan is still on the top 12 among countries with the highest case load, globally, and represents 19% of the regional burden of 1,281,924 cases. The month of June has shown the peak of cases in the country recording between 4,000 to 6,000 cases per day. Over the past 5 days, a decline has been observed; cases toll between 3,000 to 2,000.

• Since 7 June, KSA has been reporting 3,000 to 4,000 cases per day, thus, the country continues to represent 18% of the Regional burden of cases. Qatar and Egypt represent 8% and 6% of the regional load of 1,281,924 cases, respectively. Iraq now represents 6% of the regional case load while Kuwait, UAE and Oman, each, represents 4% of the regional burden of cases.

• Cumulatively, 6.0% of the global burden of COVID-19 deaths (561,617 deaths) have been reported in the EMR (31,009 deaths); in descending order, 10 countries surpassed the Regional CFR of 2.4%: Yemen, Sudan, Iran, Egypt, Iraq, Syria, Tunisia, Somalia, Libya and Afghanistan, with Yemen recording at 26%, followed by Sudan (6.3%) and Iran (5.0%).

• Over the past 24 hours, 18 countries and territory in the EMR reported 14,738 new cases, including 534 new deaths in the EMR; highest number of cases are reported from KSA (2,779), Pakistan (2,521), Iraq (2,312), Iran (2,186) and Oman (1,318).
